When I first met with a Concorde Rep. he said that once I graduated from their school they placed 98% of there students, that definately did not happen. As of 4 mos post graduation only 1 out of 7 have a job in the field of surgical technology, and this individual had no help with finding this position either. I was also told that I would be prepared for the CST exam and that they had a 80% pass rate on this exam, again that was not true, only 50% of our class passed the exam as did the graduateing class a month before mine. Then due to not being properly prepared for this CST exam the first time, I am expected to pay to re-take the exam which will cost an additional \$200.00, after I have already paid \$15,000.00 for the initial "education". In addition to the preceeding, I feel they continue to mislead new students with instructors that are unqualified and incompetent to provide the level of education that it takes to be successful in this field. Unfortunatly my realization came to little to late. My hope is that this will deter this from happening to future students. So, now I have no job, no certification, and a huge student loan coming due. Not a very good place to be. Not to mention no prospects of a career and children to support. I feel I was completely misled and should not have to pay for this "non-education". My experience with this school was far from satisfactory. I am still also inclined to add the last fact, I maintained a 3.0-3.8 GPA thru out my time at this school, so I really feel as if we just were not prepared.

Consumer's Desired Resolution:

Full repayment of outstanding student loans and I would also request to be compensated for the 13 monthes of time I wasted which if figured up comes out to be a minimum 1040 hrs, so even at a minimum wage job it would be \$6656.00.
