10/13/08- From ED: Actually came in and spoke when he dropped on Monday, Oct 6. He was very nice. He didn't think he was capable, So we shook hands and just chatted a bit. His "wife" also attends Kaplan and she said she has no intentions of quitting school and is happy here. So, we'll see what happens 10/6/08- From C-Vue: Student called to ask what the procedure would be to drop from the university. He

stated he would be transferring to Kirkwood CC. I told him he needed to come in and talk to School and sign the appropriate paperwork to complete the withdrawal process. He stated he would do that. drop from Kaplan. I told him the ramifications of being dropped and he said that he is decided. He signed the SSCR and I submitted it to this date.

10/4/08- From ED: Yes - I met with Redacted with School Academic Dean, present. did not hesitate to tell me he wrote the messag on rip off report. I asked him why and he said because we are a rip off just as he said. He clearly did not understand the academic progress requirements. School I both review with him not only the gpa requirements but the progression requirement. We informed him he has 2 more terms in which to complete his degree, not counting the term he is in. I offered him private tutoring from a work study student to help him meet sap requirements. (not in a group setting but one on one) I asked him if there was anything else I could do and he said no "this place is still a rip off and will always be a rip off". I asked him why he continues to go to school at Kaplan when he feels that way. He didn't really know. We then talked about whether or not he should be a student at the college if he truly felt it is a rip off. I again offered tutoring and asked him to make a decision as to whether or not he wanted tutoring or if he was planning to leave school. I expressed to him it is not appropriate to go around bashing an institution that he attends. He still didn't get it. But he did get upset with me for confronting him. I read the blog about the campus. Strange stuff. I don't frankly know what he is talking about. I haven't overheard anyone at lunch and have not been out to the lunch with the student advisor. I wrongly chose Kaplan University here in lowa. First and foremost the school is a plain ripoff from the get go, you pay an atonishing 30,000 for your program, which for most people is a lot of money!!! Second you have to deal with Financial Aid which for the most part is a headache in itself, I myself had to consolidate my loans but I still recieved bills from the loan company Loan Direct. I was under the assumption that I was in deferment(that was what I was told by Financial Aid) and then they screw with your living expense checks. by this I mean if you have bad attendence they withhold your money from you (a federal offense) they never cease to do this to students every term... Next they have some really challanging classes and they expect you to keep up with instructors that go to fast, you go into their academic success center only to find no tutors there to help you, from the get go Kaplan told
