Secretary Becerra:

Over the past fifteen months, I have repeatedly sounded the alarm about the Biden administration's failures to secure the southern border and the consequences this failure has had on the safety of unaccompanied children who come to the United States. As the Ranking Member of the Senate Committee on Health, Education, Labor, and Pensions (HELP), I have sent numerous letters to the Department of Health and Human Services (HHS), the Department of Labor (DOL), and private companies to determine what we can do to stop the unspeakable harm being done to unaccompanied children, including those forced into exploitative child labor. In addition, I have made multiple attempts to gather information through briefings and other communications with

HHS, DOL, and private companies. Unfortunately, HHS does not appear to have the same interest in finding solutions to this problem, as evidenced by its repeated failure to respond to my requests for information in a timely manner or to provide useful or responsive information to my oversight requests. This continued stonewalling over such a consequential issue is completely unacceptable.

Undeterred, I have searched for ways to get the answers I need, despite HHS' unwillingness to provide them. For example, after learning that HHS' Office of Refugee Resettlement (ORR) uses contractors to screen potential sponsors for the unaccompanied children in ORR's custody, my office reached out to that contractor, The Providencia Group (TPG), to schedule a briefing regarding their background and experience screening potential sponsors for unaccompanied children, the extent to which their screening process for potential sponsors is directed and overseen by ORR, and the extent to which their process has changed in light of the recent HHS Office Inspector General report finding numerous faults in ORR's own sponsor screening process.² I was surprised to learn that—despite months of dragging its feet to respond to my office's requests—ORR directed TPG, within days, not to speak to my office and to direct my questions to HHS's Office of Legislative Affairs:

Thanks for checking back. We appreciated the opportunity to speak with you and your staff earlier this week on behalf of our client, The Providencia Group (TPG). We wanted give you a head's up that the HHS Office of Refugee Resettlement asked TPG to refer you to the HHS Office of Legislative Affairs. TPG wants to make sure to understand from HHS-ORR what their view of TPG's obligations are under the contract and whether there are any limitations on information that it can provide. TPG is working to get guidance from HHS-ORR on these items and expects to have more information next week.³

In other words, ORR does not want TPG to talk to the Senate office with direct and primary oversight jurisdiction over its work, but instead wants all questions directed to the HHS office that has repeatedly failed to provide meaningful responses to legitimate oversight inquiries for the better part of a year.

It is difficult to see ORR's actions as anything other than an attempt to side-step legitimate congressional oversight that would potentially embarrass the Biden administration during an election year. Ensuring the safety of these vulnerable children, however, is not a political matter. We must work together to find solutions to ensure that, when unaccompanied children enter the United States without their parents or guardians, they remain safe from exploitation and harm. To accept anything less than full transparency from those charged with unaccompanied children's safety is an abdication of the trust and responsibility placed in us by the American people.

With this in mind, I ask that you direct your staff to ensure my office has access to all of the relevant information to conduct necessary oversight over ORR, its contractors, and the processes

by which they provide care for unaccompanied children. Pursuant to 48 C.F.R. § 5.403, I also request that HHS immediately provide my office a copy of the contracts between HHS and TPG related to screening potential sponsors for unaccompanied children.⁴

I look forward to working together on this and other important matters.
