8	Not later than September 30, 2027, the Comptroller
9	General of the United States shall report to the Committee
10	on Health, Education, Labor, and Pensions of the Senate
11	and the Committee on Energy and Commerce of the
12	House of Representatives on the work of the National
13	Breast and Cervical Cancer Early Detection Program, in-
14	cluding-
15	(1) an estimate of the number of individuals eli-
16	gible for services provided under such program;
17	(2) a summary of trends in the number of indi-
18	viduals served through such program; and
19	(3) an assessment of any factors that may be
20	driving the trends identified under paragraph (2),
21	including any barriers to accessing breast and cer-
22	vical cancer screenings provided by such program.
